- 2. Purpose of course: This course aims to present a study of the doctrine of the church, with focus on the attributes and marks of the church, the nature and necessity of ecclesiastical offices, and the means of grace, including preaching and the sacraments. Considers scriptural principles of the New Testament for the planting and revitalization of churches, various systems of polity, and compares church governments.
- 3. Course Description: It's an introduction to practical ecclesiology, from a biblical and reformed perspective. From this, two things can be deduced: ecclesiology will be considered, on the one hand, from a practical perspective, on the other, from biblical principles of the New Testament and the Reformed doctrine of the church. To guide studies in practical ecclesiology, three texts will be essentials:
